Contest Rules and Regulations

Introduction

The SCOTi Charades Contest ("Contest") is an online game of wit and creativity, where participants are challenged to guess the original prompt that produced an Algenerated image. The Contest is open to individuals who are eligible to participate, as outlined in these Rules and Regulations.

Eligibility

- The Contest is open to individuals who are at least 18 years old and are eligible to participate in online contests in their jurisdiction.
- Employees, officers, and directors of smartR AI, its parent companies, subsidiaries, affiliates, and advertising and promotion agencies, as well as their immediate family members and those living in the same household, are not eligible to participate in the Contest
- Participants must have a valid LinkedIn account and follow smartR Al's LinkedIn page to be eligible to win.
- By participating in the Contest, entrants acknowledge that they have read and understood these Rules and Regulations and agree to be bound by them.

How to Play

- The Contest will feature a series of Al-generated images posted on smartR Al's LinkedIn page.
- Participants must comment on the post with their guess about the original prompt that produced the image.
- To be eligible to win, participants must post their response on LinkedIn as a comment in the appropriate Contest post prior to the closing deadline.
- Participants can only submit one entry per image.
- Sign up for our quarterly newsletter and you can make one extra prompt entry into the contest, giving you an extra chance to win!
- No explicit or offensive content allowed.

Judging Criteria

- A panel of judges from smartR AI's marketing team will evaluate all eligible entries based on humor, creativity, and originality.
- The judges' decisions are final and binding.
